# **TOP JUSTICE OFFICIAL TO VISIT LOCAL FAITH INITATIVE**

LOS ANGELES, CALIF., JANUARY 6, 2005: J. Robert Flores, Administrator of the Justice Department's Office of Juvenile Justice Delinquency and Prevention (OJJDP) will be in Los Angeles on January 12-13, 2005 to visit the Los Angeles TenPoint Coalition, a faith-based youth crime prevention organization that has been awarded a \$600,000 grant from the Justice Department to provide mentoring and other services to African-American youth who have spent at least 3 months in juvenile detention. The Los Angeles TenPoint Coalition is a replication and affiliate of the Boston TenPoint Coalition co-founded by Rev. Eugene Rivers. The clergy-led crime-fighting initiative in conjunction with public, private and governmental partners was chiefly responsible for a 62 percent decrease in youth crime in Boston during the early 1990s.

The L.A. TenPoint Coalition is operated by Rev. Mark B. Jennings, a former print journalist for the *Ventura County Star* and *Virginian-Pilot* newspapers. Jennings is a recent graduate of Harvard Divinity School. Bishop Charles E. Blake, Pastor of West Angeles COGIC, a 25,000 member African-American church located in the Crenshaw District, has been instrumental in helping to incubate the TenPoint program in Los Angeles.

Mr. Flores was confirmed by the U.S. Senate to his position in April of 2002 and has since worked tirelessly on youth issues especially around gang violence prevention and intervention.

## Thursday, January 13, 2005

**9:30 a.m.-10 a.m**. –**Press Conference/Check Presentation Ceremony**. (North Campus of **West Angeles COGIC in the Crystal Room**) (This event will formally launch the TenPoint Re-Entry Initiative. There will be a check presentation ceremony along with remarks from dignitaries including, Mr. Flores, Bishop Charles E. Blake, TenPoint staff, Probation and select elected officials).

10:00 a.m.-11:30 a.m. –Roundtable conversation with J. Robert Flores of the U.S. Justice Department and local gang intervention and prevention agencies. (North Campus of West Angeles COGIC in the Crystal Room) Flores, director of the Office of Juvenile Justice Delinquency and Prevention, will talk about the new justice department mandate on gangs and learn from local agencies about their success and challenges.
